Hawthorne Place Condominium is pleased to offer membership to our tennis courts.

The courts include two Har-Tru clay tennis courts located behind Building Two. Membership is open to all Hawthorne Place residents, West End residents and Non-West End residents for a modest membership fee.

Court Rules and Regulations

Each member will receive a member ID badge that must be presented to the concierge in order to obtain the key to the courts. The concierge desk will be provided with a list of members and their ID #'s and will only reserve courts for authorized members.

Each member will receive Three (3) Guest(s) passes per month (May-October Only). Guest passes are required for entry onto courts - NO EXCEPTIONS.

* Child Membership is for Hawthorne Place children only under 13 years of age. Child must play with a full adult Hawthorne Place member. No guest passes for child membership.

The key to the court is available for members at the concierge desk in Building 9. Members are required to sign in/out the key and to lock the gate after use. If the key is not returned, future reservations will not be permitted.

Each member is required to sweep and roll court lines after play. Members may turn on the lights located in the Tennis Shed as needed and are responsible for turning the lights off after play.

Proper attire and appropriate behavior are required at all times. No lessons are allowed. Hawthorne Place Condominium and the Trustees and/or Managing Agent reserve the right to revoke membership from anyone violating the terms and conditions of the Courts. No bicycle on courts. No dogs allowed.

Court Reservations

Court time is available on a first come, first served basis. Each member must contact the concierge desk in Building 9 to reserve court time at **(617) 742-5509**. Reservations may be made two days in advance ONLY, beginning at 7:30 AM.

Court Availability

Daily from 7:30 AM to 9:00 PM. Courts are booked in **1 ½ hour** preset blocks of time only.
